Tá súil againn go bhfuil gach duine socraithe ar ais go sona ar scoil.

Tá roinnt nótaí faighte agaibh le cúpla seachtain anuas faoi imeachtaí éagsúla, níl sé éasca cuntas a choinneáil ar chuile rud!

Seo ceann de na nótaí is tábhachtaí a gheobhaidh sibh. Baineann sé le Scéim Ranníocaíochta Shaorálach Scoil Naithí (An Scéim). Ar an gcéad dul síos agus thar aon ní eile is é an rud is tábhachtaí faoin Scéim seo ná go bhfuil sé deonach – níl dualgas ar bith ar éinne síntiús a thabhairt muna bhfuil sé d'acmhainn acu.

Tá maoiniú breise ag teastáil ó gach scoil agus tugann scoileanna éagsúla faoi imeachtaí tiomsaithe chun airgead breise a bhailiú. Roinnt blianta ó shin shocraigh tuismitheoirí Scoil Naithí tús a chur le scéim Ranníocaíochta Shaorálach in ionad a bheith ag cur iachall ar thuismitheoirí dul amach ag bailiú airgid i rith na bliana. Tá ag éirigh go maith leis go dtí seo agus is bealach éifeachtach é chun airgead a bhailiú.

Cuireann na rudaí seo go mór le saol scoile agus oideachas bhur bpáistí. Socraíonn Comhlucht na dTuismitheoirí (An Comhlucht) an tslí ina gcaitear airgead na Scéime agus tá fáilte roimh gach tuismitheoir teacht ag cruinnithe na Comhluchta a bhíonn ar siúl ar an 3ú Máirt de gach mí.

Tá Comhlucht Naithí go hiomlán comhlíontach maidir le Rialachán Cosanta Sonraí Ginearálta.

A Thuismitheoirí, a chairde,

We hope everyone is settling into the new school year!

You have received various notes on different initiatives and goings on over the past few weeks, it's hard to keep track of them all!

This note is one of the most important you will get. It is about the Scoil Naithí Voluntary Contribution Scheme (generally referred to as the 'Scéim'). First and foremost the most important thing to remember about this scheme is that it is voluntary - there is absolutely no obligation to contribute if you are not in a position to do so.

Every school requires extra funding and some schools undertake various forms of fundraising to raise additional money. Some years back, Scoil Naithí parents decided to introduce a Voluntary Contribution scheme instead of asking parents to go out fundraising throughout the year. To date this has worked well and has been an effective means of raising money.

We really wouldn't ask if the funding wasn't required and any amount you, as a family, feel you can contribute is very welcome and literally every penny counts. However as you may know if you give a contribution of €250, Scoil Naithí will get a tax rebate of an additional €112.33, therefore the contribution is equivalent to a donation of €362.33, an amazing contribution!

The other thing to remember is that you can pay monthly in instalments if that suits you better. Paying €21 a month amounts to just over €250, for example. You can also contribute at any point during the year, however if you pay by December 31st 2018, we can claim the tax rebate for this calendar year.

Two follow-up texts may be sent as a reminder.

Scéim funds are used for, among other things, workshops run by external providers e.g. drama, dancing, science, lego, sean nós dancing, internet safety etc; computers/iPads; subsidised swimming classes (R1-R6); First Communion school party celebration; school social events, school running costs etc. (A more detailed breakdown of expenditure is included as an addendum below.)

All of these enhance and enrich life at school for our children and your generosity makes all of this possible. The Parents Association (the Comhlucht) is responsible for determining how the Scéim money is spent and all parents are welcome to come along to Comhlucht meetings, which take place every 3rd Tuesday of the month.

Comhlucht Naithí is fully compliant with the requirements of the General Data Protection Regulation.

A receipt will be issued for all cheque/cash/online donations (please advise if you would like a receipt for standing order donations).

NB: all information relating to the Scéim is <u>strictly private and confidential</u> and only accessible to the administrator of the Scéim.

Breakdown of expenditure

Thanks to donations, over €35,000 was spent during 2017-2018 and the main expenditure was as follows:

- Computers / Technology / iPads €5,150.
- Contribution towards the running costs of the school €6,000.
- ❖ Contribution towards the insurance costs €2,000.
- ❖ Workshops and activities Drama (Ray Yeates), Dancing (Adrian Gallagher), Zeeko, Anyone4Science, Lego, Damhsa ar an Sean-Nós, Student Enrichment Programme, bus to Ceoldrama in Coláiste Íosagáin, bus to Páirc an Chrócaigh, etc €7,600.
- ❖ Every year, the families of R2 enjoy a very special day celebrating their child's Chéad Chomaoineach. Comhlucht Naithí contributed €2,200 towards the costs of the Church ceremony and party in the school, flowers and smaller incidental costs incurred.
- New lights for Amharclann €5,200.
- Access for the children to Mata ar Line (an online maths website as Gaeilge) €1,600.
- The children from R1-R6 avail of a course of nine swimming lessons in Meadowbrook Dlr every year. These lessons are subsidised by Comhlucht Naithí, the cost incurred was €1,800 last year.
- School social events €490 (Slán Le Rang 6, Pizza Croke Park, Lá Spóirt)
- Accounting and Audit Fees €2,800.
- Newsletter €425.

The above costs will be included in our audited accounts and will be explained at the AGM, usually held in early December. Notice of the AGM will be circulated in advance and all are welcome to attend.
